Antidiarrheal for cattle, sheep and pigs

COMPOSITION

Each mL contains:
Benzetimidé Hydrochloride.....0.165 mg
(Equivalent to 0.15 mg de Benzetimidé)
Excipients q.s.p.....1 mL

INDICATIONS

ROUTE OF ADMINISTRATION AND DOSAGE

Intramuscular administration.

Bovine and sheep:

15 µg de Benzetimide for of weight or 1 mL each 10 Kg of weight, with a maximum of 20 mL per animal.

Pigs:

60 µg of Benzetimide for Kg of weight or 1 mL every 2.5 Kg of weight.

If is it needed, the Invespas® treatment can be repeated after 24 hours.

CONTRAINDICATIONS

Do not administer Invespas® to pregnant or lactating females.

WARNINGS

Keep out of reach of children.

SIDE EFFECTS

At therapy dose, occasionally can be observed anticholinergic effects such as tachycardia, mydriasis, tympanites (bloat) and bronchodilation.

GUARD PERIOD

Meat: 0 days.

Milk: 0 days.

CONSERVATION

- Store in a cool and dry place, at room temperature between 15º and 30º C.
- Check the expiration date on the bottle.

To be supply only with veterinary prescription.
